I, SK. SAFIQUE, S/O. SK. MAZID, aged about 38 years, by faith Muslim, resident of Kantaranguni, DVC, Adra, P.O.+ P.S.- Adra, Dist.- Purulia, (W.B.), Mobile no.-8116341528, hereby inform you kind office that on 11/06/2024 at about 11.15 PM, when I was guarding the North Institute, Adra, as Night-Guard, on and sudden 1. SUBHENDAR MUKHI S/O. SAMBHU MUKHI, 2. ADITYA MUKHI S/O. PARBINDAR MUKHI, both are resident of Vidhyasagar Colony, Near Chota Hospital, Adra, P.O.+P.S.- Adra, Distt.- Purulia, W.B., and 05 other unknown person, illegally enter into the premise of North Institute, Adra, at late night and on seeing them, I asked them to leave the North Institute Premise as the gate of the premise has already locked at 10.00 PM, as per Rule, where they started to threat me to keep mum and for I shouted them to leave, where the above named persons, started to assaulted me with bamboo stick hold by Subhendar Mukhi, for which I fell down in earth then Subhendar Mukhi with full force blow the bamboo stick on my head, where I hold by my hand and save myself, at that time Aditya Mukhi and other 05 unknown person assaulted me over my chest and other part of my body by their legs for which I sustain injury over my chest, and other part of my body and thereafter said SUBHENDAR MUKHI again blow the bamboo stick in my leg, where I sustain injury in my left knee, and on seeing the same, some person came to spot and rescue me from their hand. The above named persons also threaten me to face dire consequences when they leaved the spot.

That I was then immediately admitted to Raghunathpur Super Specialty Hospital, Raghunathpur, and since then I was under treatment of the doctor and on today (14/06/2024), I was discharged from the Hospital, thus a delay has been caused for lodging this complaint.

It is therefore requesting before your kind office, to take necessary action against the above named persons.
