Sir,

In producing here with one arrested accused namely Jagdish @ Modha Hela (50 Yrs) S/O Lt. Parma Hela of Vill- Arrah, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 20 bottles DIL KHUSH country spirit, 600 Ml. each Rs/-55 of each bottle out of them one bottle of country spirit taken from Sl. No. 1 duly sealed and labeled as sample.

I ASI Rajkumar Nandi of Adra PS do here by lodged a complaint against accused namely Jagdish @ Modha Hela (50 Yrs) S/O Lt. Parma Hela of Vill- Arrah, PS-Adra, Dist- Purulia to the effect that on 24/06/24 at about 18:45 hrs I received a information from a reliable source that one Jagdish @ Modha Hela has been stock of country spirit illegally at his Jhupri/ Shop at Lower Jhariadih. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS CC No-1485/24 dtd.24.06.24. I reached at Lower Jhariadih at about 19:15 hrs and hold raid in the Jhupri/Shop of said Jagdish @ Modha Hela and found that the said person selling liquor at his Jhupri/Shop at Lower Jhariadih and after seeing the Police party some person fled away and said Jagdish @ Modha Hela has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Jagdish @ Modha Hela selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 19.15 hrs to 19.45 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Jagdish @ Modha Hela (50 Yrs) S/O Lt. Parma Hela of Vill- Arrah, PS-Adra, Dist- Purulia under proper section of law.
