I Shankar Prasad s/o Lt- Rameshwar Prasad resident of
Upper Beniasole, Adra, P.S- Adra, Dist- Purulia would like
to inform you that I received a call from my
elder daughter Smt. Suman Kumari (Chowhan) w/o
Vijay K. Chowhan, Resident of Vill- Missionpara PS-
Adra Purulia Pin- 723121 and said that her husband and
her in-laws are brutally beating her till death
when me and my family reached the spot, I saw
that she is in very bad condition choked by the
throat and beaten on the head with a punch
on the spot she has been operated before. Her
Brother in-law Kabindra Kumar Chowhan s/o - Rajman
Chowhan and mother in-law Smt. Meena Devi w/o
Rajman Chowhan threatened us they will constantly beat
her daily if we don't give them 5 Lacks Rupees
more. After that I took my daughter to the Adra P.S
To lodge an FIR but due to my daughter's health
worsening condition we have to admit her in
Raghunathpur superspeciality hospital, Purulia. Right
now her condition is serious as she is facing
severe pain in head on which they have punched her
It has been happening from the other day of
marriage but today it was very brutal. We have
given them rupees 10 lacks already during marriage
but they are still demanding more day by day.
They have also snatched her gold jewellery
forcibly. The previous time my daughter and her
in-laws had a fight, they threatened my daughter
that they have arranged a gun and they will kill
me and my family if we come in between.

Therefore I request you to please look into this
matter positively and take necessary actions
and help us to get justice and treat this
complaint as an FIR.
