Sub: To lodge FIR against owner and driver of one NEW HOLLAND 3032 tractor having Reg No. WB55A/9141, Chassis No. NHN30320ZJL450898 and Engine No. S324E79520 with trolley loaded with sand (approx 100 CFT).

Sir,

In producing herewith, one NEW HOLLAND 3032 tractor having Reg. No. WB55A/9141, Chassis No. NHN30320ZJL450898 and Engine No. S324E79520 with trolley loaded with sand (approx 100 CFT). Today on 07.06.2024 at about 16.05 hrs. acting on source information, I ASI Amal Kr. Pati of Arsha PS along with (i) C/-1437 Soumen Kr. Pati and (ii) C/848 Priyaranjan Senapati of both of Arsha PS, Dist-Purulia, left for PS area vide C.C No. 1509 Dtd. 07.06.2024. After we reached at Beldih Bridge, under Arsha PS at 16.45 hrs, we conducted raid on the Bank of Beldih Beltola Ghat on the Bank of River Kansai under Arsha PS and found that one tractor along with trolley attached with by a hinge was present at Beldih Beltola Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Kanshai River, fled away. Police rushed to the tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending tractor. Hence, I seized the above noted tractor along with trolley in between 17.05 to 17.25 hrs and brought the tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted NEW HOLLAND 3032 tractor having Reg. No. WB55A/9141, Chassis No. NHN30320ZJL450898 and Engine No. S324E79520 along with trolley loaded with sand (approx 100 CFT) for investigation.
