Sukhendu Mudi, S/O-Lt.Mirajunjoy Mudi, Age-45years, AE & Station Manager, Arsha CCC, WBSEDC, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Azir Ansari, S/O- Lt Daman Ansari of Village - Heradih, PS-Arsha, Dist-Purulia has committed theft of electricity U/S 135(i)(b) of electricity act 2003 subsequently amendment act 2007.

On 10.06.2024 at From 01:05PM to 01:20PM I, along with Partha Chakraborty, S/O- Late Dinobandhu Chakraborty, Divisional Engineer(E), S&LP, Purulia Regional Office, Dayamoy Mahato, S/O- Late Chutulal Mahato, Purulia, Regional Office and Promod Ranjan Barman, SO, S & LP, Purulia Regional Office went to routine inspection at Heradih Village and enters in premises of Azir Ansari who was enjoying electricity unauthorisedly by connecting a wire directly from incoming terminal of the meter to the main switch and bypassing the energy meter of WBSEDC in his premises. The service connection of Azir Ansari disconnected on the spot from nearby LTOH Line of WBSEDC on 10.06.2024. During inspection we found the electrical load he was enjoying as 1.25 KW. The inspection team left the premises of the accused person at about 01:20pm.

Azir Ansari, S/O- Lt Daman Ansari of Village --Heradih, PS-Arsha, Dist-Purulia has committed an offence U/S 135(i)(b) electricity act 2003(Amendment Act 2007), so you are requested to take cognizance of this complaint and treat it as FIR.
