In producing herewith, 01(one) Blue colour POWERTRAC (439 Plus) tractor having Reg. No. WB55A/7760, Chassis No. T053392213CG, Engine No. E3440741 along with trolley loaded with sand (approx 100 CFT). To the effect that during my Spl. raid duty vide GDE No. 569 Dtd. 15.06.2024, acting on source information & as per direction of O/C, Arsha P.S, I SI Gopal Bhattacharya of Arsha PS along with (i) C/848 Priyaranjan Senapati and (ii) C/1405 Biswanath Sing Sardar both of Arsha P.S. Dist-Purulia reached at Bhandu River Ghat near Arsha College, under Arsha PS at 15.55 hrs, we conducted raid on the Bank of Bhandu River under Arsha PS and found that 01 (one) tractor along with trolley attached with by a hinge was present at Bhandu River Ghat near Arsha College on the Bank of Bhandu River. Some persons were loading sand in the attached trolley of said tractor.
