Sub: Complain against 04 (four) persons who have damage Gov. property and obstruct us to discharge our public functions in respect of shifting of Energy Meter (bearing No- L4233822, Consumer Id- 201565583) of Sri Lakhindar Paramanik, S/O- Late Gour Paramanik of Vill- Bagandih (Ajodhya Hill), P.S- Bagmundi, Dist- Purulia as per order of the Hon'ble High Court, Calcutta vide WPA – 8594 of 2024 dtd- 25.04.2024.

Sir,

With due respect, I do here by lodging complain against 1) Biswajit Paramanik S/O Lakhindar Paramanik, 2) Narayan Paramanik, S/O Lt. Gour Paramanik, 3) Smt. Anjana Paramanik W/O Lakhindar Paramanik & 4) Smt. Gita Paramanik W/O Narayan Paramanik all are of Vill- Bagandih(Ajodhya Hill), P.S- Bagmundi, Dist- Purulia.

The fact in brief is that today i.e. on 13.06.24 at about 13:15 hrs, I Sri Maruti Mahato, A.E. & S.M Bagmundi CCC, WBSEDCL went to Bagandih Village (Ajodhya Hill) under Bagmundi PS to shift the Meter (bearing No- L4233822, Consumer Id- 201565583) of Sri Lakhindar Paramanik, S/O- Late Gour Paramanik of Vill- Bagandih (Ajodhya Hill), P.S- Bagmundi, Dist- Purulia along with the staff of Mobile van and Anup Mandal, J.E. Gr- I, Indrajit Bauri, Senior TSH of Bagmundi CCC, WBSEDCL along with Police Personnel and Lady Constables of Bagmundi PS in compliance to the order of the Hon'ble High Court, Calcutta vide WPA – 8594 of 2024 dtd- 25.04.2024.

At first, the above-mentioned service connection was disconnected from the existing location and was fitted to its original location as per above mentioned order of the Hon'ble High Court, Calcutta. At that time, the above noted persons suddenly came to the spot & obstruct us to discharge our public functions. Mainly female candidates were playing the leading role and one of them was carrying LATHI. We briefed them properly regarding direction of Hon'ble High Court and requested them for several times not to interfere. But they did not pay any heed. Rather they were using filthy language to us and also threatened us with dire consequences. One Biswajit Paramanik S/O Lakhindar Paramanik of vill. Bagandih, P.S. Bagmundi, Dist. Purulia dismantled and destroyed the electric Meter (bearing No- L4233822, Consumer Id- 201565583).

Then, we returned back from that place as the said meter box was already damaged. This was a Gov. property.

Hence, I do here by requesting you to lodge F.I.R. against all the above mentioned accused persons as per law.
