Sub: Lodging of F.I.R of theft of Electricity against Tapan Paramanik
,S/o Dulal Paramanik at his Domestic premises at Vill.-Raidih,
P.S.-Bagmundih and thereby committed an offence punishable
U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

Dear Sir,

This is to inform you that, I Sri Maruti Mahato (45), S/O – Paban Chandra Mahato, A.E. & Station Manager of Bagmundih CCC of WBSEDCL received an information to the effect that Tapan Paramanik, S/o Dulal Paramanik residing at Vill.- Raidih was committing theft of Electricity at his Domestic premises by bypassing the proper registration of units by tampering the Energy meter.

Acting on this information this day 21.06.2024, I alongwith Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office, Sri Promod Ranjan Barman, S.O. of Purulia Region S & LP Unit, Sri Biswajit Kumar, TSH of Bagmundih CCC had been to the house of Tapan Paramanik at the above mentioned address. He was not present at his house. His brother Swapan Paramanik was present. We contacted him and disclosed our identity to him. On being asked he allowed us to inspect the Energy meter of WBSEDCL installed at his domestic premises against the name of the consumer namely Tapan Paramanik.

Also search for local people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises was a one storied building and the meter is installed at the entrance of that premises. Immediately, a notice was prepared duly signed by consumer representative served upon the consumer and held inspection.

During inspection, it was detected that, Tapan Paramanik had tampered the energy meter installed at Domestic premises bearing meter No: L4482562 in the name of Tapan Paramanik at the said premises to bypass the proper registration of units by tampering the meter circuit of the meter to commit theft of Electricity. Inspection also revealed that Tapan Paramanik was the actual user of the above mentioned service connection.

Immediately, on my direction Sri Biswajit Kumar, TSH of Bagmundih CCC disconnected the above mentioned service connection and removed the Energy meter bearing SI no: L4482562 after securing the installation place of the said meter from any imminent danger in future. His brother was shown the tampered meter but being asked he could not render any satisfactory explanation. He was informed about the offence committed by his brother and its penal provision.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared inspection report in the presence of consumer representative and witnesses at the spot and load assessed as 1.1KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the energy meter of Tapan Paramanik, it is well established that Tapan Paramanik was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared Seizure list in respect of the said premises and meter in presence of the consumer representative and witnesses at the spot.

The inspection was held between 01:05PM to 01:20PM today after observing all legal formalities.

It is well evident that accused Tapan Paramanik, S/o Dulal Paramanik of Vill.- Raidih has committed offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
