Sir,

In producing herewith the Two (02) arrested tractor drivers namely (i) Aghnu Kumar (46 yrs), S/O- Rengtu Kumar of Vill- Kantadih, PO- Patahensal, PS- Baghmundi, Dist- Purulia, (Driver of SONALIKA INTERNATIONAL, DI 42 HDM Power Plus bearing Eng. No- 3102NL14D1051348F33, Chasis No- GWRSR1056656S3) (ii) Shishir Gope (20 Yrs), S/O- Fani Gope of Vill- Raghunathdih, PO- Patahensal, PS- Baghmundi, Dist- Purulia (Driver of Mahindra 265 DI bearing Sl. No- NGN8364 BA, Eng. No- 005558519R5) and two (02) seized tractors (i) one blue colour SONALIKA INTERNATIONAL, DI 42 HDM Power Plus bearing Eng. No- 3102NL14D1051348F33, Chasis No- GWRSR1056656S3 and (ii) one red colour Mahindra 265 DI bearing Sl. No- NGN8364 BA, Eng. No- 005558519R5 both were fitted with trolley loaded approx 100 cft sand in each trolley under proper seizure list. I beg to submit that today (03.06.2024) I along with (1) C/913 Aditya Mandal of Baghmundi PS (2) C/1006 Sanjay Dey of SAP 11th Bn. Camp at Baghmundi P.S were performing evening mobile duty vide Baghmundi PS CC No-1447/2024, Date-03.06.2024. During evening mobile duty at about 16:45 hrs I received a source information that 02 suspicious tractors loaded with sand were coming from Patahensal side towards Karihensa village. I informed this matter to OC Baghmundi PS and after getting necessary permission I along with force left for the said place.

During my evening mobile duty at about 17:15 hrs I along with force reached at near Karihensa village and found that 02 (Two) tractors (i) one blue colour SONALIKA INTERNATIONAL, DI 42 HDM Power Plus bearing Eng. No- 3102NL14D1051348F33, Chasis No- GWRSR1056656S3 and (ii) one red colour Mahindra 265 DI bearing Sl. No- NGN8364 BA, Eng. No- 005558519R5 both were fitted with sand loaded trolley were coming from Patahensal side towards Karihensa village. On seeing the Police party near Karihensa village, the drivers of those tractors were trying to flee away. But after a hot chase, we could able to detain them. I asked the drivers Aghnu Kumar and Shishir Gope to produce valid documents in respect of said sand but they failed to produce any documents regarding lifting & transportation of sand. I interrogated them thoroughly. During interrogation, they admitted that they are dealing with illegal sand lifting from Subarna-Rekha river bed. The owners of the said tractors were also involved in this illegal lifting and transportation. Hence, I seized the 02 (two) tractors (i) one blue colour SONALIKA INTERNATIONAL, DI 42 HDM Power Plus bearing Eng. No- 3102NL14D1051348F33, Chasis No- GWRSR1056656S3 and (ii) one red colour Mahindra 265 DI bearing Sl. No- NGN8364 BA, Eng. No- 005558519R5 both were fitted with trolley loaded approx 100 cft sand in each trolley in between 17:35 hrs to 18:15 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested the said drivers namely (i) Aghnu Kumar (46 yrs), S/O- Rengtu Kumar of Vill- Kantadih, PO- Patahensal, PS- Baghmundi, Dist- Purulia, (ii) Shishir Gope (20 Yrs), S/O- Fani Gope of Vill- Raghunathdih, PO- Patahensal, PS- Baghmundi, Dist- Purulia at 18:25 hrs. I brought the said sand loaded tractors to Baghmundi P.S compound as such there is every reason to believe that the drivers and owners of the vehicles with ill motive dealing with sand illegally without any valid document.

Therefore, I pray before you that a case may kindly be started and arrange for its investigation.
