Sub: Complain against Rabi Lochan Majhi (Approx. 27 Yrs.), S/O- Abani Majhi of Vill – Baharaghutu, P.O + PS- Bandwan, Dist- Purulia to start a Specific Case U/S 46Λ(c) Bengal Excise Act. 1909.

Respected Sir,

In producing herewith one arrested accused person namely Rabi Lochan Majhi (Approx. 27 Yrs.), S/O- Abani Majhi of Vill - Baharaghutu, P.O + PS- Bandwan, Dist- Purulia with the seized articles i.e. 1) Approx. 10 (Ten) litres illicit distil liquor (CHOLAI MOD) in 01 (One) Jerican marked as Exhibit "A" from which 01 (One) Litre has been taken out in 01 (One) separate bottle from mother quantity as sample marked as Exhibit "B". I beg to submit that on 21/06/2024 at about 20:35 hrs. Table duty officer of Bandwan PS SI Sujoy Kr. Pati received a credible source information that one person namely Rabi Lochan Majhi is selling Illicit Distil liquor (CHOLAI MOD) without any valid license at his dwelling house at Baharaghutu village under Bandwan PS. Accordingly, he informed the said information to O/C, Bandwan P.S and as per his direction, I SI Pradip Kr. Mandal accompanied with evening mobile officer ASI Tarapada Mete with C/2930 Anirudhha Patra, C/3113 Dipankar Maity, C/2420 Suresh Betkar & LC/981 Bharati Murmu all are of Bandwan P.S., Dist-Purulia vide Bandwan PS C.C No- 2099/24 date-21/06/2024 left for Baharaghutu village to work out the said source information and found that the said person is selling I.D liquor (CHOLAI MOD) to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person namely Rabi Lochan Majhi (Approx. 27 Yrs.), S/O- Abani Majhi of Vill - Baharaghutu, P.O + PS- Bandwan, Dist- Purulia. On being asked, he failed to produce any valid documents / License in respect of selling of said Illicit Distil liquor (CHOLAI MOD). Accordingly, I seized and labelled all the Illicit Distilled liquor (details in attached seizure list) i.e 1) Approx. 10 (Ten) litres illicit distil liquor (CHOLAI MOD) in 01 (One) Jerican marked as Exhibit "A" from which 01 (One) Litre has been taken out in 01 (One) separate bottle from mother quantity as sample marked as Exhibit "B" as produced by the said accused Rabi Lochan Majhi from 21:05 hrs to 21.25 hrs. and prepared proper seizure list duly signed by the seizure witnesses. Then, I arrested him at 21.35 hrs. after maintaining all legal procedures regarding arrest as per Cr.P.C, NHRC guide lines and as laid down by Hon'ble Supreme Court as he committed offence U/S-46A (c) Bengal Excise Act. 1909. I would like to note down here that after local enquiry the arrest was made because a cognizable offence was being committed in presence of a Police Officer.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) Bengal Excise Act. 1909 against the arrested accused person namely Rabi Lochan Majhi (Approx. 27 Yrs.), S/O- Abani Majhi of Vill – Baharaghutu, P.O + PS- Bandwan, Dist- Purulia and arrange for it's investigation.
