Sub: Complain against Baikuntha Mahato (Male /Approx. 34 Yrs.), S/O- Sadhu Charan Mahato of Vill – Chandra, PS- Bandwan, Dist- Purulia to start a Specific Case U/S 46A(c) Bengal Excise Act. 1909.

## Respected Sir,

In producing herewith one arrested accused person namely Baikuntha Mahato (Male /Approx. 34 Yrs.), S/O- Sadhu Charan Mahato of Vill - Chandra, PS- Bandwan, Dist- Purulia with the seized articles i.e. 1) Approx. 09 (Nine) litres I/D liquor (CHOLAI MOD) in One (01) Yellow colour Jerican marked as Exhibit "A" from which 01 (One) Litre has been taken out in 01 (One) separate bottle from mother quantity as sample marked as Exhibit "B". On the lid of Jarican noted "AMBO". I beg to submit that on 23/06/2024 at about 18:15 hrs. I received a credible source information while I was engaged in Special raid duty vide Bandwan PS C.C No.- 2116/24 Date- 23/06/2024 that one person namely Baikuntha Mahato, S/O-Sadhu Charan Mahato of Vill - Chandra, PS- Bandwan, Dist- Purulia is selling Illicit Distil liquor (CHOLAI MOD) without any valid license from his dwelling house at Chandra village under Bandwan PS. Accordingly, I informed the said information to O/C, Bandwan P.S and as per his direction, myself along with C/3345 Samir Tudu, C/3365 Sk. Amir Saha all are of Bandwan P.S. Dist-Purulia left for Chandra village to work out the said source information and found that the said person is selling I.D liquor (CHOLAI MOD) to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person namely Baikuntha Mahato (Male /Approx. 34 Yrs.), S/O- Sadhu Charan Mahato of Vill - Chandra, PS- Bandwan, Dist- Purulia. On being asked, he failed to produce any valid documents / License in respect of selling of said Illicit Distil liquor (CHOLAI MOD). Accordingly, I seized and labelled all the Illicit Distilled liquor (details in attached seizure list) i.e 1) Approx. 09 (Nine) litres I/D liquor (CHOLAI MOD) in One (01) Yellow colour Jerican marked as Exhibit "A" from which 01 (One) Litre has been taken out in 01 (One) separate bottle from mother quantity as sample marked as Exhibit "B". On the lid of Jarican noted "AMBO" as produced by the said accused Baikuntha Mahato from 19:05 hrs to 19.25 hrs, and prepared proper seizure list duly signed by the seizure witnesses. Then, I arrested him at 19.45 hrs. after maintaining all legal procedures regarding arrest as per Cr.P.C. NHRC guide lines and as laid down by Hon'ble Supreme Court as he committed offence U/S-46A (c) Bengal Excise Act. 1909. I would like to note down here that after local enquiry the arrest was made because a cognizable offence was being committed in presence of a Police Officer.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) Bengal Excise Act. 1909 against the arrested accused person namely Baikuntha Mahato (Male /Approx. 34 Yrs.), S/O- Sadhu Charan Mahato of Vill – Chandra, PS- Bandwan, Dist- Purulia and arrange for it's investigation.
