Most respectfully begs to state as follows:-

1. That your petitioner/complainant as well as accused persons are permanent inhabitant of Vill.Matalpara, P.O.- K.P.Rangadh, under P.S.Hura, Dist.Purulia, and within the jurisdiction of this Id.court.

2. That on 22.4.2024 at about 12.00 <sup>noon</sup> when your petitioner taking rest at his ceurtyard after returning from begging as your petitioner by profession beggar and passed his days by begging.

3. That suddenly accused persons 1)Mahadeb Mudi, Mangal Mudi and Susilab<sup>h</sup> Mudi came at the ceurtyard of your petitioner armed with lathi, inta and other matrial started to abused your petitioner and as and when your complainant raised objection then all the accused persons started to assault your petitioner by pilting and throwing inta and other boulder whereas Mahadeb Mudi assault your complainant by lathi and at that time elder brother of your complainant rushed to the P.O.then res<sup>ist</sup> accused persons assault him



bleeding injuries on his left eye and having seen of such incident nephew Kailas came to the P.O. and then all the accused also assault him and he sustained fracture injuries over left leg.

4. That after such assault as and when village people rushed to the P.O. that all accused went away from the P. and <sup>village people</sup> they took the all ~~act~~ the injured person to local hospital at Ladhurka and for better treatment all injured referred to Purulia D.M. Sadar hospital and all injured treated ~~there~~ therein.

5. That after returning from the hospital your complainant informed the matter before the P.S. but till date nothing has been done by the P.S.

6. That having no other alternative your petitioner informed the matter to S.P. Purulia but of no good.

7. That your petitioner is very poor beggar having no any sufficient means to lodged a case as such under sec. 156(3) Cr.P.C. is required to punished the criminal as per provision of law.
