Sir,

In producing here with one arrested accused namely Ashok Mahato (42 Yrs) S/O- Lt. Jhabulal Mahato of Vill- Chariatand, PO- Sardaha, P.S- Pindrajora, Dist- Bokaro, Jharkhand, along with seized vehicle No. JH 09 AS/2599 (Tata 1512). I beg to report that on 28.06.2024 I, ASI Partha Sarathi Bose along with C/1187 Samar Kr. Maity, C/1450 Uttam Mahapatra, NVF/955 Ganapati Sing all of Hura PS were performing Spl. mobile duty vide Hura PS C.C No- 897/24 dtd. 28.06.2024 and Hura PS GDE No-1123, dtd-28.06.2024 and while we reached at near Gurda morh under Hura PS (Purulia-Bankura NH60A road) at about 10.15 hrs. we found one vehicle having Registration No. JH 09 AS/2599, was going from Bankura side towards Purulia side with rash and negligently and overturned beside the road (Bankura-Purulia NH60A road) near at Gurda morh under Hura PS. We rushed to the spot and found that the parts of body of the said vehicle has been damaged but none injured. On demand the driver of above noted vehicle failed to produce any valid documents in respect of the said vehicle and stated that the all documents kept into owner of the said vehicle. Accordingly, I seized the above noted vehicle loaded with 10 (ten) Tan Potato by preparing seizure list (details are mentioned in the attached seizure list) with a view to prosecute him U/S 279/427 IPC. The whole process of seizure was completed in between 13.35 hrs to 13.55 hrs. I also arrested the accused driver of the said vehicle as he violated sec 279/427 IPC in presence of Police party. During the time of arrest maintained all formalities regarding arrest.

Hence, I pray that a specific case U/S 279/427 IPC may kindly be initiated against the accused Ashok Mahato (42 Yrs) S/O- Lt. Jhabulal Mahato of Vill-Chariatand, PO- Sardaha, P.S- Pindrajora, Dist- Bokaro, Jharkhand driver of vehicle No. JH 09 AS/2599 (Tata 1512) and arrange its investigation.
