I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act-2007 to the effect that SWAPAN CHAKRABORTY, S/O LT. ANIL CHAKRABORTY, resident at STATION ROAD JHALDA, PS-JHALDA, Dist- PURULIA was enjoying electricity unauthorized i.e. by tempering the service cable and bypassing the meter due to this reason he has committed theft of electricity U/s 135 (I)(b) of the electricity (Amendment act-2007) on 12.06.2024 at 10.25 AM.

Entered the premises of SWAPAN CHAKRABORTY, S/O LT. ANIL CHAKRABORTY, resident at STATION ROAD JHALDA, PS-JHALDA, Dist- PURULIA consumer Id- 242083200, Meter no IPBB25745 and inspected his/ her premises. During the inspection theft of electricity was detected i.e. by tempering the service cable and bypassing of meter i.e. U/S 135(I) (b) was detected. The details of bypassing the arrangement was damage installation of the incoming wire and part of the service cable of approx 1.5 feet's by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

1. Electrical Bulb- 10 nos.
2. Fan-03nos.
3. TV-01 no.
4. Refrigerator-01 no.
5. AC-01 NO.

Out of which I seized the following.

1. Single core two wire PVC service cable approx length 1.5 ft. with bypassing arrangement.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 10.45 AM on 12.06.2024. The accused person has committed an offence U/S 135(I)(b) of the electricity act-2003 subsequently electricity (Amendment) act-2007. You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
