Respected Sir,

In producing herewith one arrested a/cd namely Tarani Kuiry (53 yrs) S/O Lt Banbharam Kuiry of Vill Dibritikar, PO-Iloo, PS-Jhalda, Dist- Purulia and seized articles viz. (i) one Sutter improvised green colour fire arms with wooden butt length approx 37 cm, butt 08 cm, body 08 cm, barrel 21 cm, with 02 (two) .303 live cartridge under proper seizure list. I, A.S.I Prakash Senapati beg to inform you that today (23/06/24) during my spl mobile duty with force namely (i) C/864-Mahabir Mahato, (ii) C/877 Basudeb Mahato & (iii) C/1353 Atanu Ganguly (vide Jhalda PS CC No 1955/24 and Jhalda PS GDE No-1076 dated-23/06/24 received on a secrete source information at 18:05 hrs that one person namely Tarani Kuiry (53 yrs) S/O Lt Banbharam Kuiry of Vill Dibritikar, PO-Iloo, PS-Jhalda, Dist- Purulia was moving suspiciously with a fire arms at Dibritikar village. Accordingly, I along with force left for Dibritikar village to work out this information. At 19:05 hrs myself along with force arrived at Dibritikar village and on seeing the Police party said Tarani Kuiry tried to flee away and after hot chase we apprehended him and on search found (i) one Sutter improvised green colour fire arms which is conceal in his left side waist & one .303 live cartridge in side the pocket of his pant and one round .303 live cartridge loaded in side this arms. On being asked he failed to produce any papers in support of possessing or keeping the said fire arms and he also disclosed his identity as Tarani Kuiry (53 yrs) S/O Lt Banbharam Kuiry of Vill-Dibritikar, PO-Iloo, PS Jhalda, Dist- Purulia. Accordingly, I seized the above noted articles from his exclusive possession in-between 19:25 hrs & 19:45 hrs under proper seizure list and being labeled properly. During seizure & label I searched for the local disinterested persons to put sign on the Seizure List as well as Label, but no public witness could be made available. After seizure I arrested him at 19:55 hrs after observing all the legal formalities regarding arrest as his offence comes under the purview of Indian Arms Act.

Hence, I pray that a specific case may kindly be started against him Under Section 25(1)(a) 27 Arms Act and arrange for its investigation.
