

Sir,

In producing herewith 01 (one) FIR named accused person namely Basanta Paramanik, (34 Years), S/O- Adarshan Paramanik of Vill.- Chaitandih, PO-Ramamati, PS- Joypur, Dist.-Purulia do here by lodged this complaint against above noted FIR named accused person to the effect that today i.e. on 12.06.2024, I along with SI Gourango Roy, C/181 Rabban Sekh & C/922 Sanjay Bauri all are of Joypur PS had been to Chaitandih village under Joypur PS for holding raid in c/w Joypur PS Case No.- 68/24 dated 11.06.24 U/S-448/325/354B/307/506 IPC vide Joypur PS GDE No.- 528 dated 12.06.24 & CC No.- 1576/24 dated 12.06.24. At about 13:25 hrs we reached in the house of the FIR named accused person Basanta Paramanik and found him available in his house. Accordingly, I detained him and during interrogation he shows arrogant and desperate behavior, saying "যা করেছি বেশ করেছি, দরকার পড়লে আবার মারবো, তোদের যা করার আছে করে নে" and when I tried to arrest him, he become violent, used criminal force and started assaulting to Police team with fist and blows. As a result, SI Gorango Roy sustained injuries and later treated at Joypur BPHC. The accused person assaulted Police personnel to deter us from discharged of Govt duty. Under this circumstances, I along with help of other forces arrested the FIR named accused person namely Basanta Paramanik, (34 Years), S/O- Adarshan Paramanik of Vill.-Chaitandih, PO- Ramamati, PS- Joypur, Dist.-Purulia at 13:45 hrs after maintaining all formalities regarding arrest and he also medically checked up at Joypur BPHC.

Therefore, I do hereby lodge this complaint against above noted FIR named accused person to start a specific case under proper section of law.
