Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Bhim Rajwar, S/O- Late Phagu Rajwar of Vill- Nutundih, P.S- Joypur , Dist- Purulia has committed an offence of electricity U/S 138 1(b) of electricity act 2003 subsequently amendment act 2007.

On 20.06.2024 at about 12:20 P.M. I, Sri Rabindranath Das (Age- 46 yrs) S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with Raushan Kumar,JE(E) Gr-II,Joypur CCC & Sristidhar Mahato, Hg. TSH, Joypur CCC entered the premises of Bhim Rajwar, S/O- Late Phagu Rajwar of Vill- Nutundih, P.S- Joypur , Dist- Purulia and found that Bhim Rajwar was enjoying electricity unauthorizedly connecting disconnected service line and enjoying power from the LTOH line of WBSEDCL. The connection of Bhim Rajwar with meter No. 5S685054 was disconnected on 01/07/2013 due to non payment of energy bill. During inspection it is found that Bhim Rajwar reconnects his service connection with LTOH line unauthorisely and enjoying power in his premises. Contractual load of his connection (Consumer ID: 242132210) is 0.48 kVA. The connection is disconnected from LTOH line with final meter reading 3352. As Bhim Rajwar, S/O- Late Phagu Rajwar committed theft of electric power, I partially seized the following articles after preparing the seizure list in presence of Raushan Kumar,JE(E) Gr-II,Joypur CCC and Sristidhar Mahato, Hg. TSH, Joypur CCC. The inspection team left the premises at 12:35 P.M.

Seized Articles:

01. PVC black colour 4 sq mm 2core alluminium cable (approx 2.5 mtr).

Bhim Rajwar, S/O- Late Phagu Rajwar of Vill- Nutundih, P.S- Joypur , Dist- Purulia has committed an offence U/S 138 1(b) Electricity Act, 2003(Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
