Sir,

In producing here with the arrested accused person namely Mantu Sah (50 yrs) S/o-Late Suleman Sah of Vill-Mukundapur PS-Joypur, Dist-Purulia brought under arrest along with seized articles as per seizure list i.e. one improvised country made pipe gun measuring about 10.5 inch, having Iron butt, body, barrel, trigger, firing pin etc, loaded with 01 (one) round live ammunition. I, ASI Susanta Mishra of Joypur PS do hereby lodged a written complaint against the above noted accused person to the effect that on 29/06/2024 at 00:15 hrs while myself along with C/-1177 Samir Das NVF/-841 Bibek Addy HG/-1435 Sachndranath Mahato (Joypur PS GDE No-1403 Dated-28/06/2024 & CC No.- 1809/24) & all of Joypur PS were engaged in Naka checking duty at Dumurdih Railgate on Purulia -Jhalda Pitch Road (SH-4A) under Joypur PS Dist-Purulia and found the above noted person was coming from Chasmore Side via SH-4A towards Joypur side and on seeing the Naka Checking party he tried to run away. Immediately the checking team apprehended the above noted accused person. I asked him why he tried to flee away. Then he made incoherent statement. I searched him on the spot and found one improvised country made pipe gun loaded with one round live ammunition which was kept in the left side of his waist concealed under the shirt. On demand of papers, he failed to produce any papers / documents in support of carrying / possessing of such fire arms and ammunition. On interrogation he disclosed his identity as noted above and made incoherent statement in respect of the purpose of possessing said fire arm and ammunition. So, it is reasonable to believe that he chose the said route pre-planningly to commit any cognizable offence at Joypur side. I seized the said fire arms and ammunition under proper seizure list in presence of witnesses as well as accused person and make over one copy of the seizure list to him and he put his signature as token of acknowledgement and also labeled the same by me. I tried my level best to sign the public witnesses but none was available as it is late night. As the above noted accused committed offence punishable under law of the land, I arrested him abiding by all the procedure as laid down in C.rPC and the latest guidelines of the Apex Court as he has violated the provision of Arms Act, 1959.

I therefore pray that a specific case may kindly be started against the accused person namely Mantu Sah (50 yrs) S/o-Late Suleman Sah of Vill-Mukundapur PS-Joypur, Dist-Purulia under proper section of law and arrange its regular investigation.
