This is to inform you that I Mr. Biswajit Banerjee, S/O- Aswani Kumar Banerjee, Age-51, residence at DB Road, PO + PS- Purulia town, Dist- Purulia. I am an employee of Narula Infrastructure Pvt. Ltd. Situated at DB Road, PO + PS- Purulia town, Dist- Purulia. I am working as an Electrical Coordinator in this company.

We have two Indus automated mobile towers named Gorjoypur-02 (IN-1063147) situated at Kotshila village under your police station area. On 01.06.2024 ^{at night} a theft incident occurred at this site. BSS Engineers Mr. Sumit Ghosh (Ph-7076598828) went to the mentioned site for some technical work. Reaching the site he observed that 3 pcs AZNA were stolen, 6 pcs CPRI cables approx. 50 mtrs, 12 pcs of jumper cables, 3 pcs RF module power cables (10 mtrs each), 3 pcs AZNA power connector, 6 pcs 10G SEP and 30 & 4 pcs of TDD jumper cables were damaged from the site.

So, therefore I am praying for you to take necessary action against incident as per law.
