P.M.

Entered the premises of BHABISYAT TANTUBAY, S/O:- KHEDAN TANTUBAY, resident at- PAGRO, PS:- KOTSHILA, Dist- PURULIA and inspected his/ her premises. During the inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSSEDCL i.e. U/S 135(i/a) was detected.

From the above arrangement he/she uses the following electrical equipments.

1. Electric Bulb 06 nos.
2. Electric Fan 03 nos.
3. TV-01 no.

Out of which I seized the following.

1. PVC single core single wire (02 nos.) cable fitted with hooking device approx length 07 feet's each. Seizure list was prepared at the site and accused person refuse to sign.

The inspection team left the premises at 03.40 P.M...on 20.06.2024. The accused person has committed an offence U/S 135(I)/(a) of the electricity act-2003 & subsequently electricity (Amendment) act-2007. You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
