I, SUBRATA DAS, son of Hirak Das, aged about 20 years, resident of VTC, Mahamadpur, Po- Belda, Sub district Narayangarh, Dist- Paschim MEDWIPUR Bardhaman (WB) do hereby inform you that on 21.05.24 at about 2 pm my father Hirak Das, son of Devendra Das, aged about 50 years when was standing in front of a tea stall at Purulia Road, near main gate of Shakambharc Ispat and power limited a truck (TATA) being no OD01AV7151 which was coming from the said factory and going towards Kulti came in a reckless manner and dashed my father. As a result my father Hirak Das sustained a serious injury and due to this accident his right leg was crushed. The driver of the said vehicle was responsible for this accident.
