Sub: FIR regarding an accidental injury sustain by HIRAK DAS, aged about 50 years, due to reckless driving by the driver of the vehicle being no OD01AV7151

Sir,

I, SUBRATA DAS, son of Hirak Das, aged about 20 years, resident of VTC, Mahamadpur, Po- Belda, ^{P.S. - BELDA} ~~Sub district - Narayangarh~~, Dist- Paschim ^{Subrata Das} ~~Bardhaman~~ (WB) do hereby inform you that on 21.05.24 at about 2 pm my father Hirak Das, son of Devendra Das, aged about 50 years when was standing in front of a tea stall at Purulia Road, near main gate of Shakambhari Ispat and power limited a truck (TATA) being no OD01AV7151 which was coming from the said factory and going towards Kulti came in a reckless manner and dashed my father. As a result my father Hirak Das sustained a serious injury and due to this accident his right leg was crushed. The driver of the said vehicle was responsible for this accident. After the said incident local people shifted my father to Haramadih Hospital, Dist- Purulia on the same day. But due to the deterioration of health my father was shifted to Sri Hospital, Kulti, Dist- Paschim Bardhaman on. For better treatment where at present he is under treatment at the same hospital.

This accident occurred due to the rash and negligent driving of the driver of the truck being no OD01AV7151 and the driver of the said truck was the sole responsible for this accident.

Under this circumstances I urge you to take immediate legal action against the driver of the said truck and for this act of kindness I shall be
