## Respected Sir,

I do hereby submit complain Suo-motto against 90/100 unknown persons to the effect that on receipt of information regarding road blockade vide Neturia PS GDE No 224 Dt. 07.06.24 at 10:25 hrs, I along with force left PS for Dishergarh Ghat (Damodar river bridge) under Neturia PS. After reaching there at about 11.00 hrs, I found that approx 90/100 unknown persons were there under agitating mood demanding for immediate cash relief for the deceased family i.e. Jibon Bauri S/O- Lt. Ranjit Bauri of Vill- Dishergarghat, PS-Kulti, Dist-Paschim Bardhaman as he expired on 05.06.24 due to Road traffic accident at Dishergarh Ghat under this PS jurisdiction. I and the officer and force of Sanctoria I/C under Kulti PS, Dist-Paschim Bardhaman talked to them and ensured them about proper police action & steps for providing the cash relief to the family as per law & Govt. sanction but many of them continued shouting & subsequently went to the road, pulled the traffic barrier in between the road & caused road blocked. They are requested not to do so but in vain. They were raising slogans demanding immediate relief. I have tried to pursue the agitator to withdraw the blockade and help police to disperse the mob as well as discharge lawful duty. It was also found more than 40/50 vehicles loaded with goods and loaded with passengers and drivers including patients etc. from Purulia side and Barakar side were detained there and subjected to enormous sufferings for a long time i.e. 11:00 hrs to 15:30 hrs. The unknown accused persons continued to be with the obstruction in public way, causing wrongfully blockade to the vehicles & passerby and thus generated danger & obstruction in state highway and also caused obstruction to police in discharging Govt. duty. After long 04 hour & 30 minutes discussion, they withdrew the blockade at about 15:30 hrs.

Therefore, I request you to start a specific case against 90/100 unknown persons under proper section of law and arrange for its investigation.
