Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Hiralal Pasi (35 yrs) S/O- Lt. Chotelal Pasi of Vill-Parbelia New Colony, PS-Neturia, Dist-Purulia with seizure of 27 pcs sealed bottles of Dil Se Country spirit containing 375 ml each (MRP @ Rs. 35/-) which were seized under proper seizure list.

I beg to submit that today (23.06.2024) while I, SI Sk. Rahaman, along with force were performing anticrime special mobile duty vide Neturia PS GDE No-918 Dt. 23.06.2024 & CC No-2139/24 Dt. 23.06.24 and acting on source information after consulting you at about 18:35 hrs reached at Parbelia Bazar and held raid in the hotel of Hiralal Pasi (35 yrs) S/O- Lt. Chotelal Pasi of Vill-Parbelia New Colony, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand he failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 27 pcs sealed bottles of Dil Se Country spirit containing 375 ml each (MRP @ Rs. 35/-) which were seized under proper seizure list duly signed by witnesses and out of it labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s-50 Cr. P.C. and handed over a copy of the same to arrestee.

The arrested accused namely Hiralal Pasi (35 yrs) S/O- Lt. Chotelal Pasi of Vill-Parbelia New Colony, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/460 Nirmalendu Sinha Mahapatra and (3) C/1303 Biswanath Majhi both are of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Hiralal Pasi (35 yrs) S/O- Lt. Chotelal Pasi of Vill-Parbelia New Colony, PS-Neturia, Dist-Purulia under proper section of law.
