Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Nayan Bauri (30 yrs) S/O- Lt. Gopal Bauri of Vill-Madandih, PS-Neturia, Dist-Purulia with seizure of 14 pcs sealed bottles of CAPTAIN Country spirit containing 600 ml each (MRP @ Rs. 155/-) which were seized under proper seizure list.

I beg to submit that today (29.06.2024) while I, ASI Pradip Chakraborty, along with force were performing anticrime evening mobile duty vide Neturia PS GDE No-1243 Dt. 29.06.2024 & CC No-2199/24 Dt. 29.06.24 and acting on source information after consulting you at about 19:05 hrs reached near Shakambhari plant and held raid in the hotel of Nayan Bauri (30 yrs) S/O- Lt. Gopal Bauri of Vill-Madandih, PS-Neturia, Dist-Purulia and found that the above noted person was keeping & selling liquor which were kept in his hotel, on demand he failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act. Accordingly, accused Nayan Bauri has been arrested U/S-67 BE Act and also 14 pcs sealed bottles of CAPTAIN Country spirit containing 600 ml each (MRP @ Rs. 155/-) were seized under proper seizure list duly signed by witnesses, out of 14 bottles 01 (One) bottle labeled as sample at the time of seizure. During arrest, I followed all the guidelines of Ld. Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative. Issued arrest memo u/s- 50 Cr. P.C. and handed over a copy of the same to arrestee.

The arrested accused namely Nayan Bauri (30 yrs) S/O- Lt. Gopal Bauri of Vill-Madandih, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/726 Dipankar Mahato (2) C/844 Tufan Sawdagar and (3) C/295 Bodrul Hazari all of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Nayan Bauri (30 yrs) S/O- Lt. Gopal Bauri of Vill-Madandih, PS-Neturia, Dist-Purulia under proper section of law.
