Plot no: 110 of mouza: Hetabahal in which the complainant has transplanted several trees like Mango trees, palash trees, Bamboo clumps etc. and the same are sufficient -ly grown in the said field. Be it noted complainant has also built a tileshed house within the said field.

- 3. That on the day of incident acced, persons in furtherance of their common intention tresspassed into the said field and cut and took away three numbers of palash trees, one number of Mango tree and one Amra tree which were sufficiently grown up under the nourishment and care of the complt. Acced. fersom also damaged the tile most of the length
- 4. That as the entire incident had taken place behind the know ledge without and permission of the complainant, thus complainant went to the acced, persons owing to the enquiry of the incident in which acced, became furious and gave out threat Tora JA KOR AR KOAR DARKARE TOR JIBAN SESH KORE DEBO, BAKI GACH GULI KETE NEBO KI KORBI DEKBO".
- 5. That owing to such offence complt, has sufferred a financial loss to the tune of Rs:-10,000/- which is the present market value of the theft property.
- 6. That complainant reported the matter to the local police station at Neturia for taking action against the acced. person but in vein thereafter complainant also sent his grievances to the 5.P. Purulia through Regd. post but it also became of no reput. Finding no other alternative complt. seeks his remembefore the d. court.
