Subject: Prayer for lodging FIR against Unknown miscreants.

Sir,

With due respect, I do hereby lodge typed complaint against unknown miscreants to the effect that on 02.06.2024 at 14.25 hrs. I SI Sujoy Kundu of Para PS received a written information from Dr. Jyoita Ghatak, M.O of Para BPHC that "a dead body is brought to emergency to Para BPHC at 14.00 hrs. one unknown aged about 35 yrs. male body is burnt". On the basis of this written information O/C Para PS started an U/D Case vide Para PS U/D Case No. 12/24 dated 02.06.2024 and per endorsement of O/C Para PS, I SI Sujoy Kundu of Para PS enquired this U/D Case. During Enquiry I along with C/315 Mir Kurban of Para PS had been to Para BPHC and prepared Surathal Report, Dead Body Challan over the unknown dead body after maintaining all legal formalities. Also a magisterial inquest has been done over the unknown dead body paralally in presence of witness. After completion of inquest I sent the dead body of unknown to the Deben Mahato Govt. medical Collage & Hospital, Hatuara, Purulia for P.M Examination to ascertain the actual cause of death under proper escort through C/315 Mir Kurban of Para PS along with all connected papers.

In-course of enquiry it is learnt that the burnt dead body was found on 02.06.2024 at about 09.30 hrs by the local people near Ranipur Railway Sub-way under Para PS. During enquiry of the UD case and preparing of surathal report a sharp cutting injury found on the back side of the head and also several injuries found over the head and face. Burnt injuries found all over the body and face of the dead body. During enquiry it is suspected that some unknown miscreants committed murder the unknown person by assaulting him on his head and burnt the dead body near Ranipur Railway Sub-way (23.470973N, 86.547606E) under Para PS with the intention to disappear the dead body.

Therefore I pray before your kind honour that a specific case under proper section of law may kindly be started against unknown miscreants and arrange for its investigation.
