Sir,

In producing herewith one seized Bolero pickup vehicle bearing registration No- WB37D/8758 along with seized 10 (ten) number of cow calf loaded in the said vehicle and do hereby submit complaint that today on 07.06.2024 from morning, I along with C/ 1175 Srikanta Mukherjee, C/1548-Subrata Pramanik, NVF/1047 Dhananjay Mahato, Spl HG-1423-Hemanta Baskey all of Puncha PS were performing day mobile duty at Puncha P.S area vide G.D.E No 253 and C.C No 1315/24, during day mobile duty at about 14.15 hrs I received telephonic information from a reliable source that one vehicle bearing registration No-WB37D/8758 loaded with cattle is coming from Manbazar side without any valid documents or proper permission from concern authority. The matter was intimated to O/C Puncha PS and as per his instruction, I along with my accompanied force reached at Puncha Gopalpur pitch road near Puncha block office at about 14.35 hrs I managed to stop the vehicle bearing Registration No-WB37D/8758 then after seeing the police vehicle the driver of the vehicle flee away from the spot leaving the vehicle. I searched the vehicle and found that total 10 (ten) number of cow calf were loaded in the above mentioned vehicles. I also searched the vehicle but could not found any documents in respect of vehicle along with loaded cow calf. I searched the available places to trace out the accused driver but could not found him. As the driver was fled away after left the said loaded vehicle, it is reasonably believed that the driver of the said vehicle has procured the vehicle and the cow calf in any fraudulent means or by means of theft after hatching up criminal conspiracy also trying to disburse that cow calf for personal gain.

The accused driver of the above noted vehicle treated the cow calf in such a manner so as subject those to unnecessary cruelty as he loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth Hence, I seized those Total 10 cow calf and the vehicle noted above from the P.O that is Puncha Gopalpur pitch road near Puncha block office under proper seizure list in presence of witnesses and brought to P.S

I, therefore pray that a case may kindly be started against the accused driver and owner of the said vehicle U/S 379/411/120B IPC and U/S 11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960 and arrange in investigation.
