Sub: Prayer for lodging FIR under proper section of law.

Sir,

In producing herewith the arrested accused driver namely Chitta Gope (29 Yrs) S/o- Lt. Juren Gope of Vill+PO- Belkudi, PS- Purulia (M), Dist- Purulia along with seized Tractor bearing Reg. No- JH 09S 8581, attached with trolley loaded with sand approx 100 cft, Seizure list and Memo of Arrest.

I beg to state that today (23.06.2024) I, ASI Navin Kr. Singh along with force (i) C/- 2078 Haripada Das (ii) C/- 2505 Anup Kundu of Purulia (M) PS left the PS for performing mobile duty vide Purulia (M) PS GDE No- 1155, Dtd. 23.06.2024 in PS area. During my mobile duty, I received a tip off at 15.05 that one suspicious tractor loaded with sand was coming from Bhul village towards Hulka village. Subsequently, I along with force proceeded towards Hulka village to work out the tip off. While I along with the force arrived at Hulka village morh on Imundih-Chharra X-ing pitch road under Purulia (M) PS, we found that 01 (one) tractor was proceeding towards Hulka village by bypass road. Accordingly, I along with the force intercepted one Tractor bearing Reg. No- JH 09S 8581 attached with Trolley, loaded with sand approx 100 cft at 16.05 hrs and detained one person. I found that the vehicle as well as goods was identical as I received prior information. On being asked, the driver of the Tractor disclosed his name as Chitta Gope (29 Yrs) S/o- Lt. Juren Gope of Vill+PO- Belkudi, PS- Purulia (M), Dist- Purulia and also stated that he is the driver of said Tractor. I asked the driver of the Tractor to produce the valid documents in respect of the Tractor as well as the loaded sand. But the driver of the said Tractor was not able to produce any kind of documents in respect of Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently at different times. The incoherent statement of the driver purported to be suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the Tractor by illegal means for selling the same to make their own profit by dishonestly and they had been running a clandestine business. So it is reasoned to believe that the alleged driver in cahoots with the owner of the Tractor procured the said sand from Bhul ~~Clat~~ of Kansai River by fraudulently or theft by any means for transporting the same to run clandestine business. So I seized the Tractor bearing Reg. No- JH 09S 8581 attached with Trolley, loaded with sand approx 100 cft under proper seizure list in presence of available witnesses duly signed by them. The seizure was done at 16.15 hrs.



Also arrested the alleged driver namely Chitta Gope (29 Yrs) S/o- Lt. Juren Gope of Vill+PO- Belkudi, PS- Purulia (M), Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest against him and also issued Check List. The arrest was made at 16.35 hrs. Thereafter, I brought the seized tractor and alleged arrested driver to Purulia (M) PS.

Under the above facts and circumstances, I therefore, pray you kindly take lawful action against the owner of seized Tractor bearing Reg. No- JH 09S 8581 and the arrested driver namely Chitta Gope (29 Yrs) S/o- Lt. Juren Gope of Vill+PO- Belkudi, PS- Purulia (M), Dist- Purulia under proper section of Law.
