Sir,

In producing herewith the arrested accused person Sk. Salimul (28 Yrs) S/o-Sk. Guffar of Vill- Hutmura, PS- Purulia (M), Dist- Purulia and beg to report that on 25.06.2024 at about 06.45 hrs I received a source information regarding presence of the above noted proclaimed accused person in his house at Hutmura village under Purulia (M) PS. Accordingly, I informed the matter to you and diarized the fact in GD vide Purulia (M) PS GDE No- 1259 Dtd. 25.06.2024. As per direction I along with (i) C/- 2735 Soumen Nayak & (ii) HG- 1576 Shaktipada Mahato left for village Hutmura, to work out the source input. On arrival at about 07.05 hrs I along with the force reached Hutmura Bazar. Subsequently, we held raids against the said accused person and managed to apprehend him from Hutmura Bazar. On interrogation he confessed that he had every knowledge regarding proclamation and attachment completed against him but knowingly he was avoiding Court order by remaining absconding. Accordingly I arrested him on 25.06.2024 at 07.15 hrs by preparing proper Memo of Arrest observing all legal formalities for violating order issued by the Ld. Court. I searched for him but found nothing except his wearing apparels. I informed his family members.

It is also noted here that as per order of Ld. Court and proclamation order had been served against them as follows-

Sk. Salimul (28 Yrs) S/o- Sk. Guffar of Vill- Hutmura, PS- Purulia (M), Dist-Purulia on 21.01.2024 vide GDE No- 1218 Dtd. 21.01.2024 and the process of attachment has been completed on 21.02.2024 vide Purulia (M) PS GDE No- 1152

Dtd. 21.02.2024 in presence of witnesses. Nil Seizere List was prepared. Though Alproclamation was served against the above noted accused person but he knowingly disoboved the order of Ld. Court.

The state of the above circumstance, I pray before you that a specific case U/S-174A IPC may kindly be initiated against the above noted accused person for non-appearance in response to proclamation against him in c/w above noted reference.
