Sub: First Information Report.

Sir,

In Producing herewith one accused person namely (1) Ananta Rajwar @ Alam (43 yrs) s/o Lt Ramnath Rajwar all are of Village- Bhabanipur, PO- Hutmura, PS- Purulia (M), Dist- Purulia, (2) Malay Rajwar @ Lula (24 yrs) s/o Ananta Rajwar @ Alam of do, (3) Sudan Rajwar (20 yrs) s/o Ananta Rajwar @ Alam of do & (4) Baidyanath Ojha @ Babu (33 yrs) s/o Lt Sanjay Kr Ojha of Hutmura, PS- Purulia (M), Dist- Purulia under arrest and following seized articles as per enclosed seizure list alongwith memo of arrest, original seizure list, this is to report that today morning at 09.05 hrs received a reliable source information that illegal, unauthorized and fake paper lotteries are being sold at different locations of Purulia District area by framing a racket under a deep rooted conspiracy for huge wrongful monetary gain of some people and wrongful loss to many poor and ordinary people and huge revenue loss of the Government and at that very moment some persons are selling that illegal, unauthorized and fake paper lotteries to common people at Joynagar Bazar under P.S- Purulia (M), Dist- Purulia. Accordingly, the information is noted in General Diary of Purulia DD, vide Purulia DD GDE No. 107 dated 28.06.2024 at 09:05 hrs and after informing superiors, I, Insp Dipankar Sarkar, DDI Purulia along with SI Ataur Rahaman, WC/T- 246 Santimoy Mondal, WC/T- 243 Animesh Pain left for Joynagar Bazar by Govt. Vehicle having No WB 24AL 2255 (vide Purulia DD GDE No 108 dated 28.06.2024 and C.C. No 41/2024) to work out the information along with SI Soumen Panda and force of Purulia (M) PS as local Police assistance (vide Purulia (M) PS GDE No 1435 dated 28.06.2024). At 10.05 hours we left Purulia (M) PS and at 10:35 hrs reached at Joynagar Bazar area. On arrival there as per the source identification, found 04 (four) persons were selling paper lotteries Joynagar Bazar, PS- Purulia (M), Dist- Purulia. The paper lotteries which they were possessing with the intention of clandestine selling, from its appearance, it was clearly believed that those paper lotteries are illegal, fake and not authorized by the state government and as a result Govt. is losing huge revenue, particularly the paper lottery with scratch panel, written 'Lucky coupon 05, Dear Jupiter 20 Lucky coupon 03, Lucky coupon 10, Lucky coupon 15' on those.

Being asked, the persons identified themselves as (1) Ananta Rajwar @ Alam (43 yrs) s/o Lt Ramnath Rajwar all are of Village- Bhabanipur, PO- Hutmura, PS- Purulia (M), Dist- Purulia, (2) Malay Rajwar @ Lula (24 yrs) s/o Ananta Rajwar @ Alam of do, (3) Sudan Rajwar (20 yrs) s/o Ananta Rajwar @ Alam of do & (4) Baidyanath Ojha @ Babu (33 yrs) s/o Lt Sanjay Kr Ojha of Hutmura, PS- Purulia (M), Dist- Purulia and stated that they had been selling these paper lotteries to the common people fraudulently and dishonestly for their illegal gain even after having clear knowledge that these lotteries are illegal, fake and unauthorized. This racket of illegal, fake and unauthorized lotteries is being run under a deep rooted conspiracy. After interrogating the arrested accused and also from local enquiry it came to learn that some other persons are also involved in this same racket. They also disclosed that, no draw for the sold lotteries is conducted naturally nobody is given any prize money to the buyers of these lotteries.

Accordingly I seized the above noted paper lotteries believed to be illegal, fake and unauthorized under proper seizure list and arrested the above noted accused communicating the ground of arrest and issuing proper memo of arrest maintaining all formalities of Hon'ble Supreme Court of India regarding arrest.

In view of the above it is requested to register a case under section 294A/417/418/420/464/465/471/120B IPC R/W Section 10 of WBG&PC Act against the arrested accused persons and some others.

As per order of Superior of CID, West Bengal, SI Amar Singh Sardar of Purulia DD, CID, WB will investigate the case.
