Most respectfully begs to state:-

 That Meghdoot Chakraborty, since deceased, S/o Lt. Saktipada Chakraborty of Huchukpara, PO & PS- Purulia, Diat.- Purulia was/is the brother of your petitioner/complainant.



- That accused no.1 is/was the wife/widow of said Meghdoot Chakraborty, S/o Lt. Saktipada Chakraborty.
- That your petitioner used to reside in a same building but in separate mess, having no direct connection with the accused person.
- 4. That said Meghdoot Chakraborty has been caused death by his wife i.e. accused no.1 namely Pratima Chakraborty in order to grab the property which comes under the share of the deceased brother of your petitioner namely Meghdoot Chakraborty.
- That your petitioner has applied for the certified copy of PM report of said Meghdoot Chakraborty being U/D Case no.-315 of 2023 dated 03/09/2023, through his lawyer under proper acknowledge receipt.
- 6. That your petitioner had been to Purulia(T) PS with a written complaint about the unnatural death of his brother namely Meghdoot Chakraborty but of no good.
- 7. That having no response of the application/letter of the Ld. Lawyer of the complainant, your petitioner applied to the S.P., Purulia as well as to the District Magistrate, Purulia under RTI Act on 29/03/2024.
- 8. That your petitioner received a letter from Dy. SP, HQ & SPIO, Purulia vide Memo no.- 981/DEB, dated 30/04/2024 received on 01/05/2024, wherein though the copy of RTI was submitted under proper acknowledgment, the letter/memo disclosed that the application was received through D.M., Purulia on 16/04/2024, suppressing the fact of received by the department on 29/03/2024.
- 9. That the Xerox copy of the letter to the S.P., Purulia and the D.M., Purulia as well as the reply have been enclosed herewith for your kind perusal and necessary action.
- 10. That more than 30 days have been elapsed but no reply, though as per the RTI Act, the reply/information should be given within 30 days. It is to be mentioned here that necessary appeal will be preferred within due time.
- 11. That it is learn that the Police of Purulia(T) PS had send civic volunteer and/or other to the accused no.1 about each and every information of filing of the application / information wanted to the accused no.1.
- 12. That being the brother of the deceased as well as an applicant, no PM report has yet been supplied to your petitioner, the reason is obvious otherwise.
- 13. That it is to be mentioned here that the certified copy of PM report can be given to the petitioner several times subject to payment of cost but the memo no. 981/DEB dated 30/04/2024 goes to show otherwise. It may be mentioned here that no reply has yet been received from S.P., Purulia and District Magistrate, Purulia. It is further be mentioned here that delegated power cannot be redelegated. And further it is well known comment of Hon'ble Apex Court that "A King can do no wrong" but non-



supplying of PM Report of the deceased to his brother and the memo no.- 981/DFB dated 30/04/2024 and the averment made therein are clearly violation of the verdict of Supreme Court of India as well as natural justice.

- 14. That whenever your petitioner wants to report the matter, he was threatened in dire consequences.
- 15. That this petition/s 156(3) CrPC, in order to start a case against the wrongdoer i.e. accused persons to unearth them and book them and punished them as per the Law.
- 16. That as the matter required thorough investigation and, so this petition is required to be send to the O/C, Purulia(T) P.S., u/s-156(3) of the Cr. P.C. to treat the same as an FIR and to book the wrongdoer under the provision of LP.C.
- 17. That your petitioner has not filed any other case relating to the same matter before any authority against the accused person, named above.

It is therefore prayed that your Honour will be graciously pleased to send this petition to the O/C of Purulia(T) P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr.P.C. and to start a case and investigate in accordance with law to unearth the wrongdoer(s) and booked them, so that they can face the trial before the appropriate court of law and further be please to pass such order(s) as your honour deem and proper.
