Sub: Prayer for lodging F.I.R. against arrested accused person Kanchan Roy (47 yrs approx) S/O- Mathur Roy of Ketika, Ward No- 09, PS- Purulia (T), Dist. - Purulia.

Sir,

In producing herewith one arrested accused person namely Kanchan Roy (47 yrs approx) S/O- Mathur Roy of Ketika, Ward No- 09, PS- Purulia (T), Dist. - Purulia under arrest alongwith following seized articles under proper seizure list and being labeled properly:-

- (1) 15 (Fifteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP and MRP is Rs 55/-, Total amount Rs. 825/- being sealed properly)
- (2) Out of 15 (Fifteen) bottles 01(one) bottle is kept as sample.

I, ASI Bachchu Ghosh, beg to report that while I was performing RT mobile duty vide Purulia (T) PS GDE No- 1273, Dated- 20.06.2024, at about 20:25 hrs received a secret telephonic information from source that one person namely Kanchan Roy (47 yrs approx) S/O- Mathur Roy of Ketika, Ward No- 09, PS- Purulia (T), Dist. - Purulia, is selling country spirit illegally at a higher price causing unlawful gain to him by unlawful loss to the purchasers at his Goomty near Ketika More under Purulia (T) PS .

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of C/3192 Tarun Sahoo and C/1516 Sushanta Kapri all of Purulia (T) PS proceeded to work out the information.

At 20:55 hrs we reached near Ketika More and keeping our Govt. vehicle at a reasonable distance we preceded towards his Goomty as shown by the source from the distance and after reaching his Goomty found that the said person was selling Country Spirit as noted above to some persons, some persons were found drinking there. Seeing the police, all of them fled away from the spot. On hot chase seller could be nabbed. On interrogation he confessed his guilt as he was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any license in favour of selling, keeping or possessing Country Spirit and the said person disclosed his identity as noted above. On search of his Goomty we found 15 (Fifteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP and MRP is Rs 55/-, Total amount Rs. 825/- being sealed properly). As such at about 21:15 hrs to 21:25 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and seal properly. I also took 01 (one) bottle as sample out of 15 (fifteen) bottles and arrested him at 21:35 hrs observing all the formalities as the said person committed an offence which attracts sec. 46 A (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
