Sub: Request to lodge FIR regarding Illegal detention of L&T Staff & workmen in front of DVC main gate & physically assaulted on 21.06.2024 at around 10:30am.

Sir,

This is to inform you that some local people have stopped our staff bus & other vehicles in front of DVC main gate on 21.06.2024 at 08:30 am & prevented entry of L&T workmen & staff to the DVC plant premises. Their demands are to engage 20 persons nominated by them in L&T work with immediate effect. We conveyed them that our work is in final stage & we are reducing our workmen gradually as per the work volume reduces. However, we have invited them to come to our office for discussion to resolve the issue. They were rigid on their demands & asked the assurance for recruiting their nominated persons on the spot itself. We denied giving any recruitment at the spot & request to come to plant office. But they were firm with their decision & did not allow us to enter DVC plant premises.

Around 10:30 am during conversation few of them asked for some assurance from us. Suddenly the gathering became violent & started using filthy language. When we protested the same, they became more violent & some of them namely- 1) Bhabani Bauri 2) Gobinda Gorain 3) Dinu Bauri 4) Sanjay attacked us physically & started manhandling our staff & one of them hit me on my face just below my left eye causing serious injury & threatening me with intent to kill me. On seeing this other staffs rushed to save me then they also were assaulted with fist & blows. As a result myself along with Mr. Ketan Kumar Patel, Mr. Asharaf Raza, Mr. Prashant Nair, Mr. Shubham Mishra (all are engineers) sustained serious injuries. They also damaged the mobile phone of Mr. Shubham Mishra (One of the staff who were manhandled).

After the incident they left the spot & we have entered the plant premises. Injured staffs were medically treated at Raghunathpur Super Speciality Hospital.

We therefore request you please take appropriate strong legal action against the aforementioned persons who assaulted our staff as per law.
