I, Biswanath Koiborto s/o Late Gangadhar Koiborto resident of Thekara, Post Godi Bero, Raghunathpur, District Purulia, West Bengal 723133. I work as a guard at ChandiMandir and take care of the Chandi Mela area. I would like to bring to your notice criminal activities of 1. Ashish mandal s/o Kistopada Mandal 2. Rajkumar Mandal s/o Shyamapada Mandal 3. Rabilochan Majee S/O Late Gopal Majee all residents of Puratan Bero, Post Godi Bero, Raghunathpur.

lam the night guard of Chandi Mandir, Mouza Paschim Bero, Post Godi Bero. Everyday I go to Chandi Mnadir at around 8PM and stay till morning 6 Am at the temple premises. However yesterday i.e 01.06.2024 as it rained heavily i got delayed. I arrived at around 10:30 PM. When I reached near the gate of the Temple premises I heard a sound coming from the temple. I immediately rushed towards the temple and saw 1. Raj Kumar Mandal 2. Ashish Mandal and 3. Rabilochan Majee who had forcefully broken the locks of hundi (donation box) and was taking out money from the box. I immediately protested but they overpowered me and pushed me and threatened me that if I inform anyone they will kill me. Ahish Mandal was carrying a hammer , Raj Kumar Mandal was carrying a dagger (katra) and Rabilocahan Majee was carrying lathi. Rajkumar Mandal tried to attack me with the dagger but I somehow ran away from there to save my life.

The lock of one of the hundi was broken and all the donation money present inside were stolen away.

In view of the above I request you to please take strict action against the accused and ensure stringent punishment is awarded.
