Dear Sir,

This is to inform you that I, SUJOY MONDAL S/O DHANANJOY MONDAL is presently posted at STPS Thermal Plant at Santalalidih in the Post Manager (P.S) under dept.- Operation and residing at Company provided accommodation at STPS Township in Qtr. No.- C-87.

On the morning of 12.06.2024, I had to go the house of my in-laws at Murshidabad keeping my quarter vacant. At 06:00 hrs on 12.06.2024 I left my quarter after properly putting 02 nos. locks for Morning shift duty and on the way I informed and put on record my period of absent from 12.06.24 to 14.06.24 at the Security office register and the guards present at that time in the office. After performing duty I left Santalalidih directly.

At around 20:00 hrs I received a phone call from STPS Security In-Charge that there were no locks visible at the main gate. After checking it was found that the locks were broken. Then they informed Santalalidih Police Station and then they

found that some miscreants had entered the Qtr and vandalized the place and theft has occurred.

Then I reached STPS T/S on 13.06.2024 at around 17:00 hrs and informed Police Station. I along with the presence of Police entered my Quarter and found the following items missing :-

1. Cash - Rs. 10,000 approx.
2. Silver ear ring - 01 no.
3. Silver chain and pendent - 01 no.
4. Smart watch - 02 nos. (1 Boat & 1 Aqbit)
5. Normal watch - 03 nos. (02 Gents & 1 Ladies)
6. 1 Full Key Set.
7. Baby Gold ring - 01 no.
8. Silver Pen
9. Normal Stone Jewellery Set
10. Oxidise Metal Jewellery (Ladies)
11. Power Bank - 01 no., Hair dryer - 01 no.
12. Nose Ring of Gold - 01 no.
13. Gold earring - 01 Set.

Also they have broken and damaged 03 nos. of My Steel Admirals.

So, I request you to kindly look into the matter and recover the items and also look into security of my family as I will be residing in the same Qtr. for now.
