In producing herewith the driver namely Manish Mahto (28 yrs) S/O - Raju Mahto, Ward No-16, Garhsisai, , PS-Vidhyapati Nagar, Dist-Sarmastpur, Bihar-848503 along with seized Truck bearing Registration No.WB25E/9807 loaded with sand and attached with Seizure list, Memo of Arrest in respect of the above noted driver before you.

The fact of the case in brief is that on 01.06.2024 I, ASI Subhendu Maity of Santuri P.S along with C/1058 Taran Malla & C/324 Rajkumar Bouri both of Santuri PS were performing mobile duty at Poradiha under Santuri PS. During mobile duty on 01.06.2024 at about 03:05 hrs received credible source information that one Truck is coming from Madhukunda Side under Santuri PS loaded with sand towards Saltora side. At about 03:25 hrs we found that one truck is coming from Madhukunda side. We intercepted the said truck at Poradiha naka post. Found that the Reg. No of the truck is WB25E/9807 and it is loaded with approx 18 MT sand. On being asked, the driver of the vehicle disclosed his identity as Manish Mahto (28 yrs) S/O - Raju Mahto, Ward No-16, Garhsisai, , PS-Vidhyapati Nagar, Dist-Sarmastpur, Bihar-848503. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. So there is every reason to believe that the driver in conspiracy with the owner of vehicle procured the said sand form Damodar River bed by fraudulent means or theft by any means for transporting the same. Finding no other alternative I, seized the Truck bearing Registration No.WB 25E/9807 loaded with sand (approx 18 MT) under proper seizure list in presence of available witnesses duly signed by them and also arrested the accused driver namely Manish Mahto (28 yrs) S/O - Raju Mahto, Ward No-16, Garhsisai, PS-Vidhyapati Nagar, Dist-Sarmastpur, Bihar-848503 after informing the ground of his arrest and issued Memo of Arrest against him. Thereafter, I brought the seized sand loaded truck to Santuri PS compound.


