I, Lakhmi Kanta Sinha Mahapatra (51 Yrs) S/O- Lt. Sudhir Baran Sinha Mahapatra of Sir. Vill- Kundulia, PO- Fulmati, PS- Taldangra, Dist- Bankura, SI of Police of Tamna PS, Dist-Purulia, along with force returned at PS and in producing herewith (i) One blue colour New Holland 4010 seized Tractor without number plate but one paper pasting in the body but digits are not readable having Engine No. F79197 & Chassis No. NH6293985 attached with trolley without number plate loaded with sand approx. 100 cft. (ii) 04 (four) PCs Shovel and (iii) 02 (two) Pcs iron basket. I lodged this complaint to the effect that on 03.06.2024, myself along with force i) C/752 Durjadhan Sing Sardar and ii) C/195 Santosh Sing Sardar were performing PS area day mobile duty. During my mobile duty at about 14.05 hrs received a credible source information that one Blue colour Tractor is carrying sand illegally from Kansai river bed near Telidih pump house. Accordingly, myself along with force left to work out the said source information. At about 15.25 hrs. when we reached near Telidih pump house under Tamna PS, Dist-Purulia found that driver and other 02-03 unknown persons engaged for loading sand from Kansai river on a trolley which was attached with the said tractor. But seeing the Police party all are fled away leaving the said tractor on Kansai river bed near Telidih pump house under Tamna PS. We tried to apprehend them but failed. So, there is every reason to belief that the owner and driver of above noted tractor dealing in sand business in clandestine manner. We waited for reasonable time but none came forward and produce any proper challan or any valid documents related to the said loaded sand of above detained tractor. So, I seized the said blue colour New Holland 4010 Tractor without number plate but one paper pasting in the body but digits are not readable having Engine No. F79197 & Chassis No. NH6293985 attached with trolley without number plate loaded with sand approx. 100 cft. (ii) 04 (four) PCs Shovel and (iii) 02 (two) Pcs iron basket. Bring the Tractor at PS after arranging driver from our force.

On return to Tamna PS, kept the aforesaid seized tractor attached with trolley without number plate and other seized articles at PS compound and I do hereby submit complaint before you to start a specific case against the owner & driver of the said tractor having Engine No. F79197 Chassis No. NH6293985 and other 2-3 unknown persons under proper section of law.
