I ASI Raj Kumar Nandi of Adra PS do here by lodged a complaint against accused namely Chitta Bauri (67 Yrs) S/O Lt. Ratan Bauri, Vill-Sarberia, PS-Adra, Dist- Purulia to the effect that on 04/07/24 at about 18:10 hrs while performing table duty I received a information from a reliable source that one Chitta Bauri has been stock of country spirit illegally at his Jhupri/ Shop at Sarberia Village. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left for work out the information vide Adra PS CC No-1592/24 dtd.04.07.24. I reached at Sarberia village at about 20:05 hrs and hold raid in the Jhupri/Shop of said Chitta Bauri and found that the said person selling liquor at his [hupri/Shop at Sarberia village and after seeing the Police party some person fled away and said Chitta Bauri has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.
