Subject:- written complaint against my husband and other in laws for physical and mental torture and assault.

Respected sir,

I Smt. Madhu Ojha wife of Krishnakant Ojha daughter of Brathnath Ojha resident of village Umedpur, police station Brhampur, District- Baxer, State- Bihar (matrimonial house) at present resident of Kamasthan, post and police station- Adra, Dist- Purulia (WB) (Parental House) do here by lodge this written complaint with a effect that, I am the only legally married Hindu wife of Krishnakant Ojha son of Kanhiya Ojha resident as mention above, and our marriage was solemnized on 08/03/2008 at village- Karaja post office- Umraogang, police station Biheya, Dist- Bhojpur State- Bihar according to Hindu rites, customs, usages prevalent in our society in presence of both the family members, friends, relatives etc. and at the time of marriage as per demand of my husband my father has paid of Rs. 2.5 Lakhs cash in hand and other valuable articles such as gold, silver, almirah, devan bed, dressing table, utensils etc, which deem to be "Stridhan Articles" which are solely entitled by me. Since marriage my husband and other in laws i.e my mother in law, father in law, brother in law and sister in law disclosed that the dowry article which was given at the time of marriage by my parents was not only grossly inadequate but also below standard as such I was subjected to continuous mental harassment and physical torture by my husband and his family members. Due to marital wed-lock we have been blessed with 2 (Two) male children namely Aushman Ojha aged about 14 years and Areman Ojha aged about 9 (Nine) years. My husband was working in Navy and now he has retired from his service on 30/04/2022 and since retirement my husband came to his native place at village Umedpur, and does not do any other job. After passing 1 year from my marriage I was shifted to Mumbai (husband's working place) from Umedpur village, wherein my husband on multiple occasions, has physically assaulted me, causing injuries. Several times my parents mitigate the matter amicably. I have lived by compromise for 16 years. I have been constantly harassed and mentally tortured by my husband and in-laws. They have subjected me to verbal abuse by using filthy languages, threats, and undue pressure to bring more dowry. I have been also denied to financial resources. Recently on 06/07/2024 at about 7 am, my husband inconvenience with my mother in law namely Vishnu Pyari Devi and father in law namely Kanhaiya Ojha, brother in law namely Santosh Ojha and sister in law namely Mamta Devi told me to bring more additional dowry from my father of Rs. 5 lakhs for purchasing a car. When I protest such unlawful demands they con-jointly assaulted me and my child with fist and blows and my mother in law also assaulted me in my face, head and my eye with fist and blows. My father in law also assaulted in my belly by his leg. My brother in law also slaps me in my face and my sister in law also assaulted me in my chest as such I sustain huge pain. My husband also caught holds

his hand in my throat with a view to kill me. I was beaten badly by my husband and other in-laws as such I sustain bleeding injury in my face anyhow by the intervention of my elder son they stop beating me. Then they drove me out from my matrimonial house and threatened with dire consequences. Thereafter I called my brother Ashok Ojha and narrated the incident and my brother came to my matrimonial home and rescues me and took me at Adra (West Bengal). Thereafter I treated medically by the doctors at Raghunathpur S.D. Hospital. My husband consumes all kinds of drugs like drinking alcohol, ganja and heroin. My husband stopped taking responsibility of me as well as stops expenses of our minor child. Due to the continuous physical and mental torture, I am living in constant fear for my safety and well-being.

I request you to take immediate and appropriate action against my husband and in-laws under relevant sections of law for cruelty, assault, and any other applicable offenses.

I kindly urge you to register my complaint and initiate an investigation into the matter at the earliest. I am also seeking protection from further harassment and threats.

Thank you for your prompt attention to this grave matter.
