In producing here with one arrested accused namely Partha Banerjee (46 Yrs) S/O Lotan Banerjee of Vill- Kamlasthan, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest

1) 13 bottles DIL KHUSH country spirit, 600 ML. each Rs/-55 of each bottle out of them one bottle of country spirit taken from Sl. No. 1 duly sealed and labeled as sample

I SI Shoumik Acharyya of Adra PS do here by lodged a complaint against accused namely Partha Banerjee (46 Yrs) S/O Lotan Banerjee of Vill- Kamlasthan, PS-Adra, Dist- Purulia to the effect that on 14/07/24 at about 19:15 hrs while performing special raid duty I received a information from a reliable source that one Partha Banerjee has been stock of country spirit illegally at his Jhupri/ Shop at Kamlasthan Power House. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left for work out the information vide Adra PS CC No-1691/24 dtd 14.07.24. I reached at Kamlasthan Power House at about 19:45 hrs and hold raid in the Jhupri/Shop of said Partha Banerjee and found that the said person selling liquor at his Jhupri/Shop at Kamlasthan Power House Area and after seeing the Police party some person fled away and said Partha Banerjee has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid license or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Partha Banerjee selling the country spirit by illegal way I seized the above mentioned articles under proper seizure list with proper videnography duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 19:50 hrs to 19:55 hrs

Hence I there for pray that a specific case may kindly be started against arrested accused Partha Banerjee (46 Yrs) S/O Lotan Banerjee of Vill- Kamlasthan, PS Adra, Dist- Purulia under proper section of law.
