I Sandhya Kumari Giri W/o Kartik Giri and D/o Ajoy Giri, Resident of Adra South Side near Harizan Basti Palaskola, P.O./P.S.- Adra District-Purulia(W.B.), would like to draw your kind attention that 28.7.2024 about 1.00 P.M. when I was asked my husband for our baby's food and other expendature at that time few words have been exchanged between asked on that very time suddenly all the above said accused persons came and started abusing me with filthy languages and betten marcyless ly . I tried to stop them with my level best but all the persons attacked me direly. The brother of my husband hold my neck tightly and tried me to kill on very spot. On the other hand my mother-in-law holds my hair tightly and drag me to another room by this time other co-accused are keep my belly, chest ,face back etc. It is partinent to mention here during that time the wife of Ganesh Giri namely Priyanka Debi ee a knief and make a cut on my forehead with collaboration of my husband, Father-inlaw and Mother-inlaw. I was bleeded and they also force me to fatch money from my patternal house to meet all my and my minor female child namely Anesha Giri's expendature

Kindly note that it is not the first time they have assulted and beten me, many times they have did so, but to maintain 40 the peace in my family and considering the situation of my minor female child I have not come before the Police station. Now it is extreem and high situation to intimate you about the incident so that the wrongdoer may get proper punishment before the court of law. The above said accused persony also threaten me with mm dire consequences to do not make any alligation regarding the same otherwise they will kill me in next time. Any how I managed to save myself and wont to Adra Police Station, lodging complain against the above accused persons during that time while going to Plice Station some soft heartted person of locallity help me to stop my bleeding and show me the path of Police Station. After reaching Police Station the concern police Officer told me to go Hospital after getting treatment of my wonds I am coming before your Police Station to report the occurance held with me .
