Sir,

In producing here with one arrested accused person Rajesh Dutta (32 yrs) S/O Dayamay Dutta of vill- Tumbajhalda, P.S.-Arsha, Dist-Purulia along with following seized articles.

- 1) 12 Bottle of country sprite marks as "Dil Se", 600 ML each bottle & Rs-55/- each bottle (55x12=660/-)  
(One bottle taken out of the above as sample packed, labeled and sealed with sealing wax)
- 2) 03 Bottle of Kingfisher Beer . 650 ML each bottle & Rs- 125/- each bottle (125x16=2000/-)  
(One bottle taken out of the above as sample packed, labeled and sealed with sealing wax)
- 3) One white colour plastic container containing approx 08 ltrs. of ID liquor.  
(Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, ASI Sisir Kr. Gope of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 27.07.2024 at about 21.45 hrs. during my Spl. raid duty at Arsha PS area, receive source information over telephone that the above noted accused has been selling ID liquor at Tumbajhalda village under Arsha P.S. On receiving the source information, I communicated with O/C Arsha PS over telephone and as per his direction I along with C/- 1526 Sanat Kr. Senapati of Arsha P.S and C - 223 Kamakshya Majee of SAP 7th BN work out the information vide Arsha PS GDE No. 996 & C.C. No. 2040 dtd. 27.07.2024. Reaching at Tumbajhalda village at about 22.05 hrs. we fixed-up in the house of Rajesh Dutta (32yrs) S/O Dayamay Dutta of vill- Tumbajhalda, P.S.-Arsha, Dist-Purulia found that selling of Country sprite, Foreign liquor and Id Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehend the above noted accused persons namely Rajesh Dutta (32yrs) S/O Dayamay Dutta of vill- Tumbajhalda, P.S.-Arsha, Dist-Purulia was selling foreign liquor, Country sprite and I.D Liquor which he use to sell clandestinely to make his profit. On demand he failed to produce any valid documents in support of selling foreign liquor, Country liquor and I.D Liquor. Accordingly, I seized all those articles after preparing a proper seizure list and put label on all the seized articles from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses and one bottle of foreign liquor and country liquor seizure was taken as sample which was also duly labeled and approx 500 ml taken from the white colour plastic container as sample packed with sealing wax with label. It took time from 22.25 hrs. to 22.45 hrs. During interrogation he confessed his guilt. Therefore, I arrested him at 22.55 hrs after observing all the formalities issuing memo of arrest.

Under the above circumstances I, therefore, pray that a specific case u/s 46 (A)(c) of The Bengal Excise Act may kindly be registered against said Rajesh Dutta (32yrs) S/O Dayamay Dutta of vill- Tumbajhalda, P.S.-Arsha, Dist-Purulia under proper section of law.
