Sub: Lodging of F.I.R of theft of Electricity against Swapan Gorain
,S/o Lt Mathur Gorain at his Domestic premises at Vill.-Raidih,
P.S.-Bagmundih and thereby committed an offence punishable
U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

Dear Sir,

This is to inform you that, I Sri Maruti Mahato (45), S/O – Paban Chandra Mahato, A.E. & Station Manager of Bagmundih CCC of WBSEDCL received an information to the effect that Swapan Gorain, S/o Lt Mathur Gorain residing at Vill.- Raidih was committing theft of Electricity at his Domestic premises by bypassing the proper registration of units by tampering the Energy meter.

Acting on this information this day 23.07.2024, I alongwith Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office, Sri Promod Ranjan Barman, S.O. of Purulia Region S & LP Unit, Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit had been to the house of Swapan Gorain at the above mentioned address. He was not present at his house. His wife Manju Gorain was present. We contacted her and disclosed our identity to her. On being asked she allowed us to inspect the Energy meter of WBSEDCL installed at his domestic premises against the name of the consumer namely Swapan Gorain.

Also search for local people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises was a two storied building and the meter is installed at the entrance of that premises. Immediately, a notice was prepared duly signed by consumer representative served upon the consumer and held inspection.

During inspection, it was detected that, Swapan Gorain had tampered the energy meter installed at Domestic premises bearing meter No: L05179389 in the name of Swapan Gorain at the said premises to bypass the proper registration of units by tampering the meter circuit of the meter to commit theft of Electricity. Inspection also revealed that Swapan Gorain was the actual user of the above mentioned service connection.

Immediately, on my direction Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP disconnected the above mentioned service connection and removed the Energy meter bearing SI no: L05179389 after securing the installation place of the said meter from any imminent danger in future. His wife was shown the tampered meter but being asked she could not render any satisfactory explanation. She was informed about the offence committed by her husband and its penal provision.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared inspection report in the presence of consumer representative and witnesses at the spot and load assessed as 1.85KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the energy meter of Swapan Gorain, it is well established that Swapan Gorain was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared Seizure list in respect of the said premises and meter in presence of the consumer representative and witnesses at the spot.

The inspection was held between 11:35AM to 11:50AM today after observing all legal formalities.

It is well evident that accused Swapan Gorain, S/o Lt Mathur Gorain of Vill.- Raidih has committed offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
