Sir,

In producing herewith the one arrested tractor driver namely Dilip Kumar (42 Yrs), S/O- Nandachal Kumar of Vill- Karru, PS- Baghmundi, Dist- Purulia and seized one MAHINDRA B 275 DI tractor bearing Reg No- WB 55A 5168 & Eng. No- R/NE04965 was fitted with trolley loaded approx 100 cft sand under proper seizure list. I beg to submit that today (15.07.2024) I along with (1) C/1471 Sankar Ruhidas, (2) C/321 Tulidas Roy, (3) C/2578 Chanchal Ruhidas all are of Baghmundi PS were performing evening mobile duty vide Baghmundi PS CC No-1834/2024, Date-15.07.2024. During evening mobile duty at about 21:35 hrs I received source information that one suspicious tractor loaded with sand was coming from Charida side towards Baghmundi Bazar. I informed this matter to O.C. Baghmundi PS and after getting necessary permission I along with force left for the said place.

During my evening mobile duty at about 21:55 hrs I along with force reached at near Tata Hotel on SH4 and found that one (01) seized tractor MAHINDRA B-275 DI bearing Reg No- WB 55A 5168 & Eng. No- R/NE04965 was fitted with sand loaded trolley was coming from Charida side towards Baghmundi Bazar. On seeing the Police party near Tata Hotel, the driver of the tractor was trying to flee away. But after a hot chase, we could able to detain him. I asked the driver Dilip Kumar to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, he admitted that he is dealing with illegal sand lifting from Subarna-Rekha river bed. Hence, I seized the MAHINDRA B 275 DI tractor bearing Reg No- WB 55A 5168 & Eng. No- R/NE04965 was fitted with trolley loaded approx 100 cft sand in between 22:05hrs to 22:25 hrs under proper seizure list in presence of available witnesses duly signed by him and I arrested the said driver namely Dilip Kumar (42 Yrs), S/O- Nandachal Kumar of Vill- Karru, PS- Baghmundi, Dist- Purulia at 22:25 hrs. I brought the said sand loaded tractor to Baghmundi P.S compound as such there is every reason to believe that the driver of the vehicle with ill motive dealing with sand illegally without any valid document.

Therefore, I pray before you that a case may kindly be started and arrange for its investigation.
