Sub: Complaint against Thakurdas Gope (36 yrs) S/O- Lt. Ramesh Gope of Vill-Shyamnagar, P.S-Balarampur, Dist. Purulia to start a specific case U/S 46A(c) B.E. Act. of 1909.

Respected Sir.

In producing here with one arrested accused person Thakurdas Gope (36 yrs) S/O- Lt. Ramesh Gope of Vill- Shyamnagar, P.S-Balarampur, Dist. Purulia along with seized 10(ten) bottles country sprit style as 'DIL SE' each bottle containing 600 ml (MRF each Rs-55/-) (details of seized articles are mentioned in attached seizure list), to the effect that today on 05.07.2024 I SI Apurba Das along with C/285 Sebabrata Mahapatra & C/206 Jhantu Khan both of SAP 11th Bn camp at Balarampur PS, Purulia was engaged in Spl. mobile duty vide Balarampur PS CC No-1945/2024 dt-05.07.2024. In course of mobile duty at about 22.15 hrs. I received an information from a reliable source that one person have stocked some illicit liquor and at a abandon house at Karbala Bypass beside NH-32 under Balarampur P.S & selling the same to innocent people for his personal gain. Accordingly, I informed to O/C Balarampur P.S. regarding this matter and as per his direction I along with force left for Rangadih Hemal Para village to work out this information. Thereafter as per source at 22.35 hrs we reached at Karbala bypass, I along with force held raid and found that one person is selling ID liquor. On seeing the Police party the person tried to flew from the place. I along with force chased him and managed to apprehend the person. On asked the apprehended person disclose his name as Thakurdas Gope (36 yrs) S/O- Lt. Ramesh Gope of Vill- Shyamnagar, P.S-Balarampur, Dist. Purulia. On interrogation he confessed that he was selling country sprit at Karbala bypass in lieu of money for his personnel gain.

Myself along with force and the apprehended person search the abandon house at Karbala Bupass under Balarampur and found that 10(ten) bottles country sprit style as 'DIL SE' each bottle containing 600 ml (MRF each Rs-55/-) is stocked there. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said ID liquor. Accordingly, I seized the following articles from the possession of accused person after preparing proper seizure list duly signed by the witnesses. I also prepared labelled. Then I arrested him after preparing proper arrest memo as he committed offence U/S 46A(c) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

The Audio & Videography of entire processes of search and seizure has been done. The

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(c) B.E. Act against the arrested accused person Thakurdas Gope (36 yrs) S/O- Lt. Ramesh Gope of Vill- Shyamnagar, P.S-Balarampur, Dist. Purulia to start a cog case U/S 46A(c) B.E. Act and arrange for its investigation.
