## The Officer In-Charge. Balarampur Police Station. Dist- Purulia.

Sub: Prayer for lodged FIR.

Sir,

In producing here with 01 (One) Tractor (Mahindra B 275 DI) attached with trolley, having bearing Registration No- WB 55A 5249 loaded with sand approx. 100 cft. I beg to state that today, that is on 11.07.2024 I ASI Manas Kumar Pan along with C/2370 Tapas Masanta and C/-2844 Indrajit Majhi performing special mobile duty vide Balarampur PS GDE No-539 Dtd. 11.07.2024 with Govt vehicle. At about 20.25 hrs we reached near Balarampur Bypass more under Balarampur PS and received a source information about transportation of sand with intent to sell to other destination by illegal means.

I informed the same to OC Balarampur PS and as per his direction myself along with accompany force reached at Haspur more under Balarampur PS on Balarampur-Barabazar road and started NAKA checking from 20.55 hrs. At about 21.20 hrs we found one Tractor was coming from Haspur village toward our Naka point and seeing the Police party the driver fled away after keeping the Tractor beside the road near Haspur morh under Balarampur PS, we chased the driver but somehow, he managed to escape under the cover of darkness. We searched all nearby places but nobody turns up for its ownership of the Tractor. Accordingly, I seized the Tractor (Mahindra B 275 DI) attached with trolley, bearing Registration No- WB 55A 5249 loaded with sand approx. 100 Cft. under proper seizure list duly sign by witnesses. The seizure was done in between 21.22 hrs & 21.30 hrs.

The Audio & Videography of entire processes of search and seizure has been done. The videography has been stored in SD Card which is enclosed here with.

Held an enquiry about the matter and so far, information collected it is crystal clear that the driver and the owner of the vehicle collected the sand by illegal mean with intent to make unlawful profit by unlawful collection of sand through illegal manner by unauthorized extraction and removal of mines & minerals. By this way they violated the regulation of procurement of mine & minerals. As such there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting the sand illegally without any valid document in support of carrying sand. As such they were doing illegal business activities.

Under the above facts and circumstances, I pray before you that kindly take needful action against the driver and owner of the Tractor (Mahindra B 275 DI) attached with trolley, bearing Registration No- WB 55A 5249.
