With respect to the Subject mentioned above it is hereby informed you that, we created a plantation in 2022 under Namami Gange Plantation scheme on RS Plot No – 352 & 1254 which is originating from CS plots -477 & 312 of Mouza – Parbaid-kashitanr, JL No – 02 under Ghatbera Beat of Balarampur Range, which is Notified protected Forest Land vide Gazette Notification No. -1529 for 5<sup>th</sup> March ,1966 ,page no.613 (Photo Copy Enclosed). In earlier along with damaging of Govt. property, all the saplings of the said plantation had been uprooted by Bahadur Mandi S/O Ananda Mandi of vill – Khendraghutu, P.O – Ghatbera, P.S.- Balarampur, Dist – Purulia and he also threatened , misbehaved, used slang languages and assaulted our staffs of Balarampur Range several times. In the meantime the said person obstructed our staffs in discharge of Govt. duty properly.

On 23.07.2024 at about 12.45 pm I, R.O/Balarampur went to visit the said plot along with B.O/Ghatbera, staffs of Ghatbera Beat of Balarampur Range and JFMC Members of Khuntar JFMC. In the meantime Bahadur Mandi S/O Ananda Mandi of vill – Khendraghutu, P.O – Ghatbera, P.S.- Balarampur, Dist – Purulia doing encroach the said Forest Land again by ploughing then we said him to stop to do this illegal activities. Then he assaulted us and started using slang language and also threatened to beat our staffs with spade.

In this circumstances, you are requested to lodge an F.I.R in proper section, so that we can protect the Plantation and forest land.
