Sub: Complaint against Subodh Gorai (24 yrs) S/O- Bholanath Gorai of Vill- Beradih, P.O- Nekre, P.S- Balarampur, Dist. Purulia to start a specific case U/S 46A(c) B.E. Act of 1909.

Respected Sir,

In producing here with one arrested accused person Subodh Gorai (24 yrs) S/O- Bholanath Gorai of Vill- Beradih, P.O-Nekre, P.S-Balarampur, Dist. Purulia along with seized approx 20 (twenty) litres ID liquor in a white colour plastic jarican (details of seized articles are mentioned in attached seizure list), to the effect that today on 19.07.2024, I ASI Nimai Rajwar along with C/2754 Sunirmal Banerjee, C/3350 Swapan Kr. Saw all of Balarampur PS, Purulia was engaged in Spl. mobile duty vide Balarampur PS CC No-1870/2024 dt-19.07.2024. In course of mobile duty at about 21:05 hrs. I have received an information from a reliable source that one person has stored some illicit liquor at his own house at Vill-Beradih, P.O- Nekre under Balarampur P.S & selling the same to innocent people for his personal gain. Accordingly, I informed to O/C Balarampur P.S. regarding this matter and as per his direction I along with force left for Beradih village to work out this information. At about 21:25 hrs I along with force reached at Beradih village and contact with my source. From a reasonable distance my source has identified the house where the ID liquor has stored illegally. I along with force held raid and found that one person is selling ID liquor which is stored in a jarican. On seeing the Police party the person has tried to flew from the place. I along with force chased him and managed to apprehend the person. On asking the apprehended person discloses his name as Subodh Gorai (24 yrs) S/O- Bholanath Gorai of Vill- Beradih, P.O-Nekre, P.S- Balarampur, Dist. Purulia. On interrogation he confessed that he is selling the ID liquor in lieu of money for his personnel gain.

Myself along with force and the apprehended person search the house at Beradih village under Balarampur P.S and found that he has stored ID liquor in a 20 litre jarican. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said ID liquor. Accordingly, I seized the following articles from the possession of accused person after preparing proper seizure list duly signed by the witnesses. I also took one litre sample in a plastic bottle from the mother container. And I sealed and labelled all the articles on the spot. The seizure procedure was done in between 21:50 hrs to 22:05 hrs. Then I arrested the person Subodh Gorai (24 yrs) after preparing proper arrest memo as he committed offence U/S 46A(c) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

The Audio & Videography of entire processes of search and seizure has been done. The videography has been stored in memory card which is enclosed here with.

Under the above circumstances, I therefore pray that a specific case may kindly be started U/S 46A(c) B.E. Act against the arrested accused person Subodh Gorai (24 yrs) S/O- Bholanath Gorai of Vill- Beradih, P.O- Nekre, P.S- Balarampur, Dist. Purulia and arrange for its investigation.
