Sub: Complain against Jaharlal Baskey, (Age-54 Yrs) S/O- Lt. Rupchan i Baskey resident of Vill-Medidih. PS-Bandwan, Dist-Purulia to start a Specific Case U/S 46A(c) Bengal Excise Act. 1509.

Respected Sir.

In producing herewith one arrested accused person namely Jaharlal Baskey, (Age-54 Yrs) S/O-Lt. Rupchand Baskey, resident of Vill-Mudidih, PS-Bandwan, Dist-Purulia with the scize, a ticles i e. 1) One black colour bucket containing Illicit Distilled liquor 20 (Twenty) litres approx marked as Exhibit "A" from which 01 (One) Litre has been taken out in 01 (One) separate Refina plastic bottle from mother quantity as sample marked as Exhibit "B". I beg to submit that today (05/07/2024) at about 19:05 hrs. Table duty officer of Bandwan PS SI Pradip Kr. Mandal received a credible source information that one person namely Jaharlal Baskey is selling Illicit Distilled liquor (CHOLAI MOD) without any valid license at his dwelling house at Mudidih village under Bandwan PS. Accordingly, he informed the said information to OAC, Bandwan P.S and as per his direction, I, ASI Suman Kr. Basu and forces being accompanied by SI Suvajit Nandi and other constables and lady constables all are of Bandwan P.S, Dist-Purulia vide Bandwan PS C.C No- 185/24 date-05/07/2024 left for Mudidih village to work out the said source information and held raid at the house of above noted person at Mudidih village. During raid I seized one black bucket containing illicit distilled liquor of approx 20 litre. On being asked, he revealed his identity as Jaharlal Baskey, (Age-54 Yrs) S/O- Lt. Rupchand Baskey, resident of Vill-Mudidih, PS-Bandwan, Dist-Purulia but failed to produce any valid documents / License in respect of selling of said Illicit Distil liquor. Accordingly, I seized and labelled all the Illicit Distilled liquor (details in attached seizure list) i.e 1) One black colour bucket containing Illicit Distilled liquor 20 (Twenty) litres approx marked as Exhibit "A" from which 01 (One) Litre has been taken out in 01 (One) separate Refina plastic bottle from mother quantity as sample marked as Exhibit "B" as produced by the said accused Jaharlal Baskey from 19:45 hrs to 20:25 hrs. and under proper seizure list duly signed by the police witnesses and the entire process of search and seizure was videographed as per provisions of sec 105 /BNSS. During preliminary interrogation it came to light that the accused person Jaharlal Baskey is partially deaf. So, I arrested him at 21,00 hrs. after obtaining permission from SDPO, Manbazar as per provisions of 35(7)/BNSS and obviously maintaining all legal procedures regarding arrest as per guide lines of BNSS as he has committed offence U/S- 46A (c) Bengal Excise Act, 1909, I would like to note down here that the arrest was made because a cognizable offence was being committed in presence of a Police Officer.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) Bengal Excise Act. 1909 against the arrested accused person namely Jaharlal Baskey, (Age-54 Yrs) S/O- Lt. Rupchand Baskey, resident of Vill-Mudidih, PS-Bandwan, Dist-Purulia and arrange for it's investigation.
